- Flemish Deaf Parliament aims to provide opportunities for deaf community members to actively participate in addressing concerns about the future.






#### **Deliberative democracy**

## **Sources of inspiration**

- Research experiments of deliberative democracy (Fiskin, 1990s)
  - citizens with different perspectives are able to develop practical proposals
- Internationational initiatives of deliberative democracy and participatory citizenship: Iceland (2010-2012), Ireland (2013)
- International initiatives of deliberative democracy and participatory citizenship in Flanders and Belgium
  - G-1000 (2011): citizens in a politically divided context such as Belgium are able to make informed decisions
  - 'Citizen budgets' in local governance and Flemish cities

## **Ostbelgian Model: Permanent citizen council**



- The German-speaking Community of Belgium
- 77,000 citizens
- 2019: Parliament of German-Speaking Community voted a decree in support of a permanent citizen council of 24 citizens
- First region in the world with a permant citizen dialogue in addition to parliament
- Inspired by G-1000



- January April 2014: over 350 signers gathered at local deaf clubs
- Topics disussed: education, employment, deaf elders, deaf heritage

#### A participant's perspective

"I am watching a lot of political television programmes; deaf people should also be politically active so that they learn how they can give their opinion. ...

Deaf people feel appreciated when they have an opportunity to have a say about employment, elderly deaf people, and discrimination. This enables them to develop self-confidence and feel equal to hearing people."

# **Findings**

- A platform for learning and reflection of deaf citizens in the face of transitions, with opportunities for listening, putting forth opinions, considering different views, add to the debate.
- A platform for learning to deal with differences between people and develop empathic and dialogical capacities.
- Participatory platforms for deaf citizens are valuable for political and democratic practice

#### A participant's perspective

"I had looked forward to the first assembly of Flemish Deaf Parliament and was very curious. Actually, I had thought that the debate would develop in a negative way, but... we really did listen to each other's opinions on social affairs, media, education, employment, public transport, etc. ... It is just a pity there was not enough time for all subjects to be covered...

It would a good idea if Flemish Deaf Parliament would gather often in the future and that, for example, workshops would be organized to deepen some topics." (Alain Wuytjens, in *Dovennieuws*, 2014, p. 4; translation by GDC)
